I acknowledge that I am aware that Australian law (s234, *Migration Act 1958*) provides a penalty of up to 10 years' imprisonment for the presentation of forged or false documentation, or the making of a false or misleading statement to an officer exercising powers under the *Migration Act*.

I acknowledge that, if documents presented with my financial guarantee are found to be counterfeit, fraudulently altered or improperly obtained, this can be taken into account as a relevant consideration by Australian authorities when considering a future visa application by me, and/or members of my immediate family.

I acknowledge that Australian authorities may, subject to law and procedures surrounding the disclosure of my personal information, work collaboratively with relevant Bangladesh authorities to investigate the suspected commission of offences under Bangladesh law relating to the manufacture and presentation of counterfeit, fraudulently altered and improperly obtained documents.
